On the day of the Holiday Market our "Holiday Helpers" will individually assist each child with their shopping and the wrapping of their gifts. Your child will only be able to select gifts for the people on his or her shopping list.

In the past we have had 95 - 100% participation from the children present at school on the day of the Holiday Market. If your child is absent from school the day of the Holiday Market, you will be given a full refund.
